“Ragging is totally banned in the institution, and any one found guilty of ragging and/or abetting is liable to be punished appropriately”

Ragging means:-

Any conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or indiscipline activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

Punishments

- Suspension from attending classes and academic privileges.
- Withholding/withdrawing scholarship/fellowship and other benefits.
- Debarring from appearing in any test/examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- Suspension/ expulsion from hostels.
- Cancellation of admission.
- Rustication from the institute for period ranging from 1 to 4 semesters.
- Expulsion from the institution and consequent debarring from admission to any other institution for a specific period.
- Fine ranging between 25,000/- and Rupees 2.5 lakhs.
- Collective punishment:- when the persons committing or abetting the crime of ragging are not identified from a group, the institution shall resort to collective punishment.

RAGGING IS STRICTLY PROHIBITED

Violation Attracts Punishment Under Prohibition Of Ragging Act

'RAGGING' means doing an act which causes or is likely to cause insult or annoyance or fear or apprehension or threat or intimidation or outrage of modesty or injury to a student

RAGGING WITHIN OR OUTSIDE THE INSTITUTE IS PROHIBITED

OFFENCE

☛ Teases or embarrasses or humiliates.

☛ Assaults or uses criminal force or
Criminally intimidates.

☛ Wrongfully restrains or wrongfully
Confines or causes hurt.

☛ Causes grievous hurt or kidnaps or
Abducts or rapes or commits unnatural
Offence.

☛ Causes death or abets suicide.

PUNISHMENT

Imprisonment upto SIX MONTHS or fine upto
Rs. 1,000/- or both.

Imprisonment upto ONE YEAR or fine
Upto Rs.2,000/- or both.

Imprisonment upto TWO YEARS or fine
Upto Rs.5,000/- or both.

Imprisonment upto FIVE YEARS and
fine upto Rs.10,000/-

Imprisonment for LIFE or upto TEN
YEARS with fine upto Rs. 50,000/-

DISMISSAL OF STUDENT

☛ A student convicted of an offence and
Punished with imprisonment.

Dismissal from the Institution.

☛ A student convicted of an offence and
Punished with imprisonment for more
then Six months.

Shall not admitted in any other
Educational Institution.

SUSPENSION OF STUDENT

Without prejudice to the foregoing provisions, whenever any student complains of ragging, the Head of the institute shall inquire into or causes an inquiry to be made into the same forthwith and if the complaint is prima-facie found true, shall suspend the student or students complained against for such period as may be deemed necessary and lodge complaint with Police.

THE DECISION OF THE HEAD OF THE INSTITUTE SHALL BE FINAL.
