Bulk Wi-Fi service was provided to RVR&JC College of Engineering and commissioned on 23-08-2017 with 100 Mbps 1:1 Internet Leased Line as backhaul bandwidth separately. 50 Nos of Access Points were installed in the campus as mentioned below.
