The disciplinary committee meeting was convened and thoroughly enquired the students involved in the incident which was happened on 27th June, 12 at Guntur. The disciplinary committee ascertained the facts to lead the fighting of the students and the following are the recommendations.

1. The students involved are warned severely and collected the written statements from them. They have been informed that their involvement in future in such type of indiscipline activity will lead to summarily **dismiss** in future.
 2. Mr.R.Venkatesh (Y10 EC890), reported to committee along with his father on 29-06-2012. The student and his parent have expressed their regret for involvement in this incident. During the enquiry the written statements from the student has been collected. He may be permitted to attend classes from 5-07-2012.
 3. Mr. Ch.Ujesh Reddy (Y10IT880), has not reported to committee, even though he has been served the memo to appear before the committee. The convener disciplinary committee and HOD, IT contacted his parent and passed the information to attend before the committee on 4-07-2012. Due to his absence before the committee, his suspension is pending.
 4. 



1. The students were counseled, warned severely and collected the written statements from them. They have been informed that their involvement in future in such type of in-disciplinary activity will lead to summary dismissal from college.
2. During investigation, the committee observed that K.Nani, Y17CE081; V.Ratnakar, Y17IT114; V.Gowtham, Y17IT109; K.Raj Koushik, Y17IT061 man handled and teared the Shirt of N.Siva Prasad, T18CEB038 for the dispute arose between himself and with K.Nani.
3. It is also observed that K.Raj Koushik, Y17IT061, is staying in the hostel illegally in the room of V.Ratnakar, on the pretext for preparation of the exams, without permission from the Principal / Hostel authorities.

For illegal stay in the hostel, K.Raj Koushik, Y17IT061 should award the punishment of making the payment of Hostel Fee for One Semester. For allowing K.Raj Koushik to stay in his room, V.Ratnakar, Y17IT114 should also make the payment of fine of an amount of Rs.5,000/- to the Hostel authorities.
